Snyder's acclaimed book was named one of the New York Times "Top 10 Books of the Year," National Book Critics Circle Award Finalist, and most recently a Los Angeles Times Book Prize finalist.

"While we struggle with the COVID-19 pandemic, we need to recognize that there is a shadow pandemic of domestic violence happening behind closed doors," Snyder said. "The UN estimates an additional 31 million victims of domestic violence globally during the next six months because of COVID-19; this number is alarming, certainly.

"But it is also a call to action. We cannot hope to solve it, to address the needs of scores of victims and their children, if we don't start locally," she said. "The issue is always important. Now, it is urgent, because #stayathome does not always mean #safeathome."
